



Houghton Village, a 50-unit townhouse community located at 27 – 80 Hamlet Street in Newton Centre is accepting rental applications for its 2, 3 and 4-bedroom **waitlist** for the Workforce Housing Program (10 units). Spacious apartments featuring washer/dryer hookup in unit, semi-private rear patio and all appliances included. Walking distance to MBTA, shopping and dining in Chestnut Hill and Newton Centre. Houghton Village is home to the NCDF Youth Center, offering programs and activities for young residents.

Households must be income eligible for the Workforce Housing Program which is available through financing under the guidelines of MassHousing. Rents are established at below market rates and do not change based on applicant's income.
